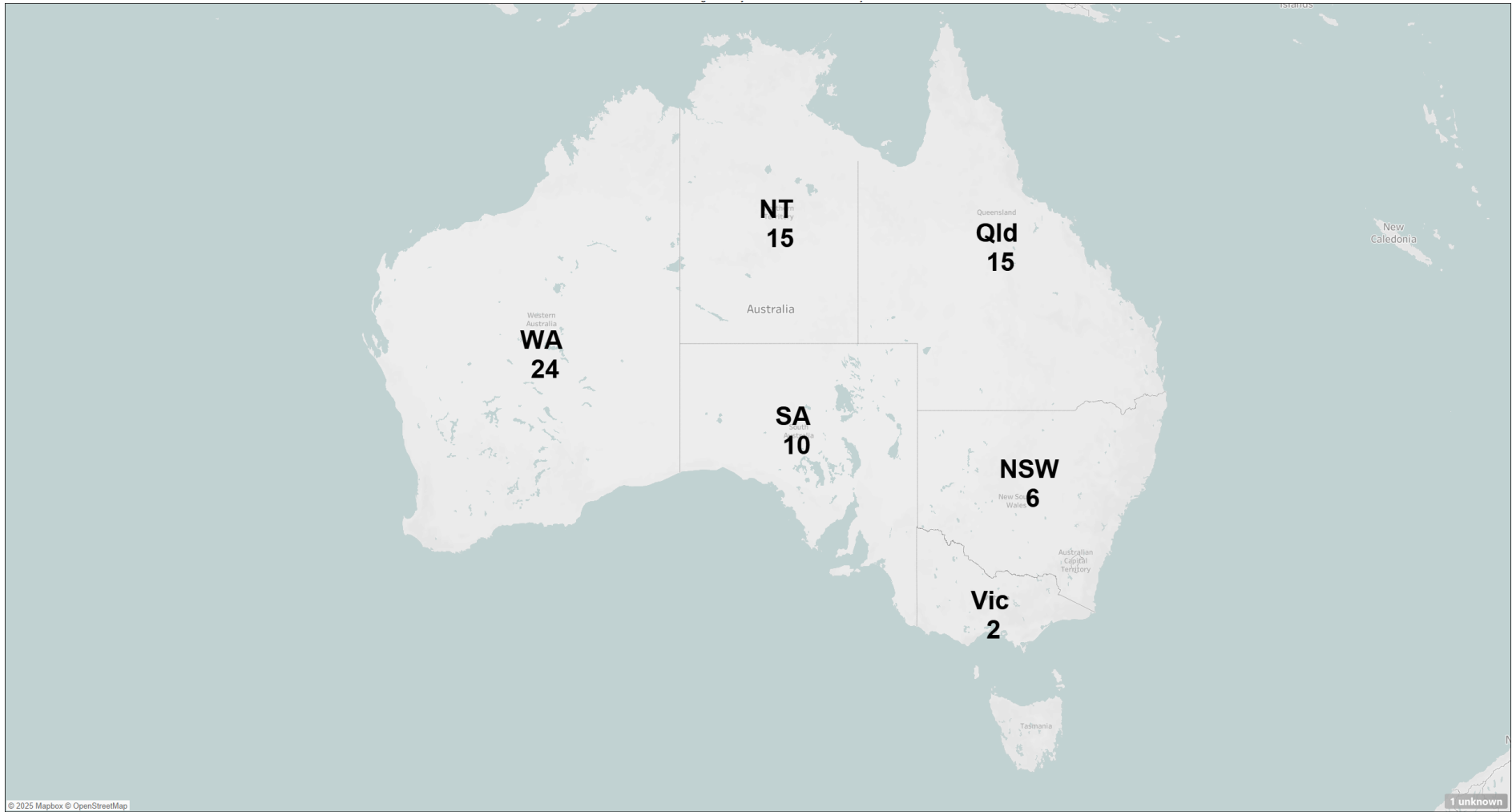

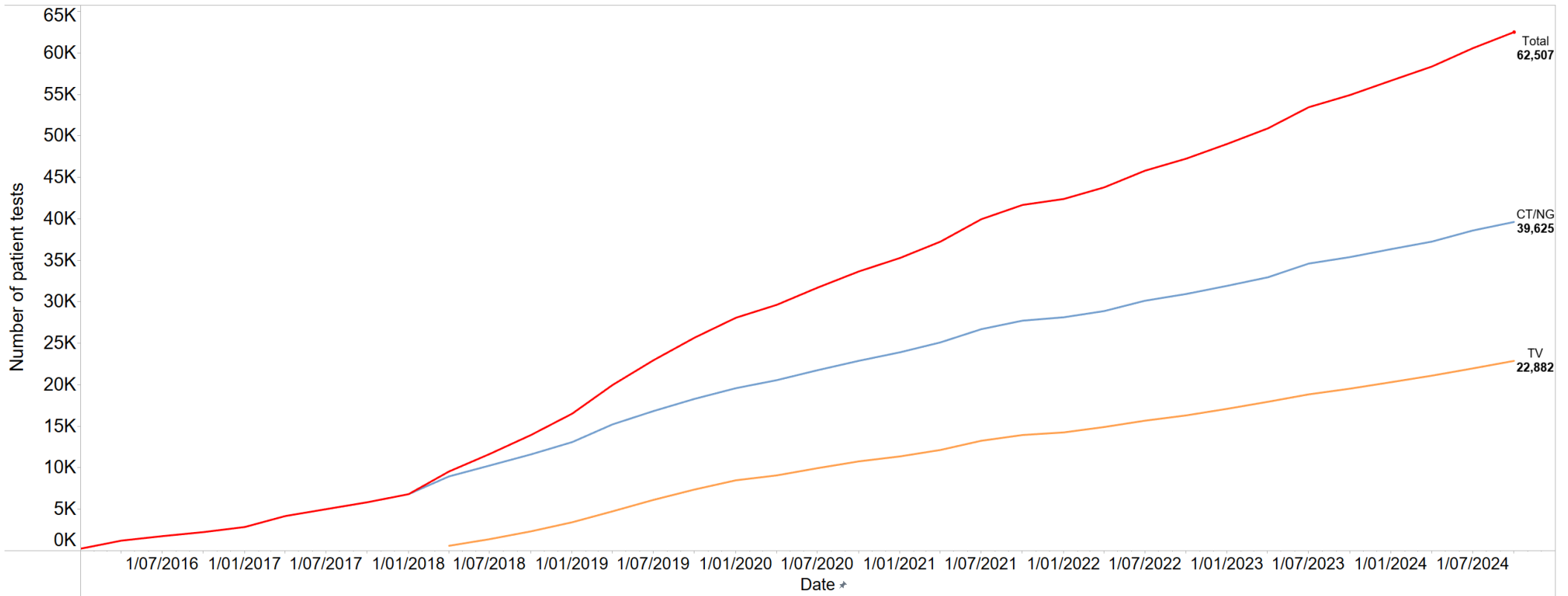

2. Cumulative CT/NG/TV POC patient tests over time, Q1 2016 – Q4 2024



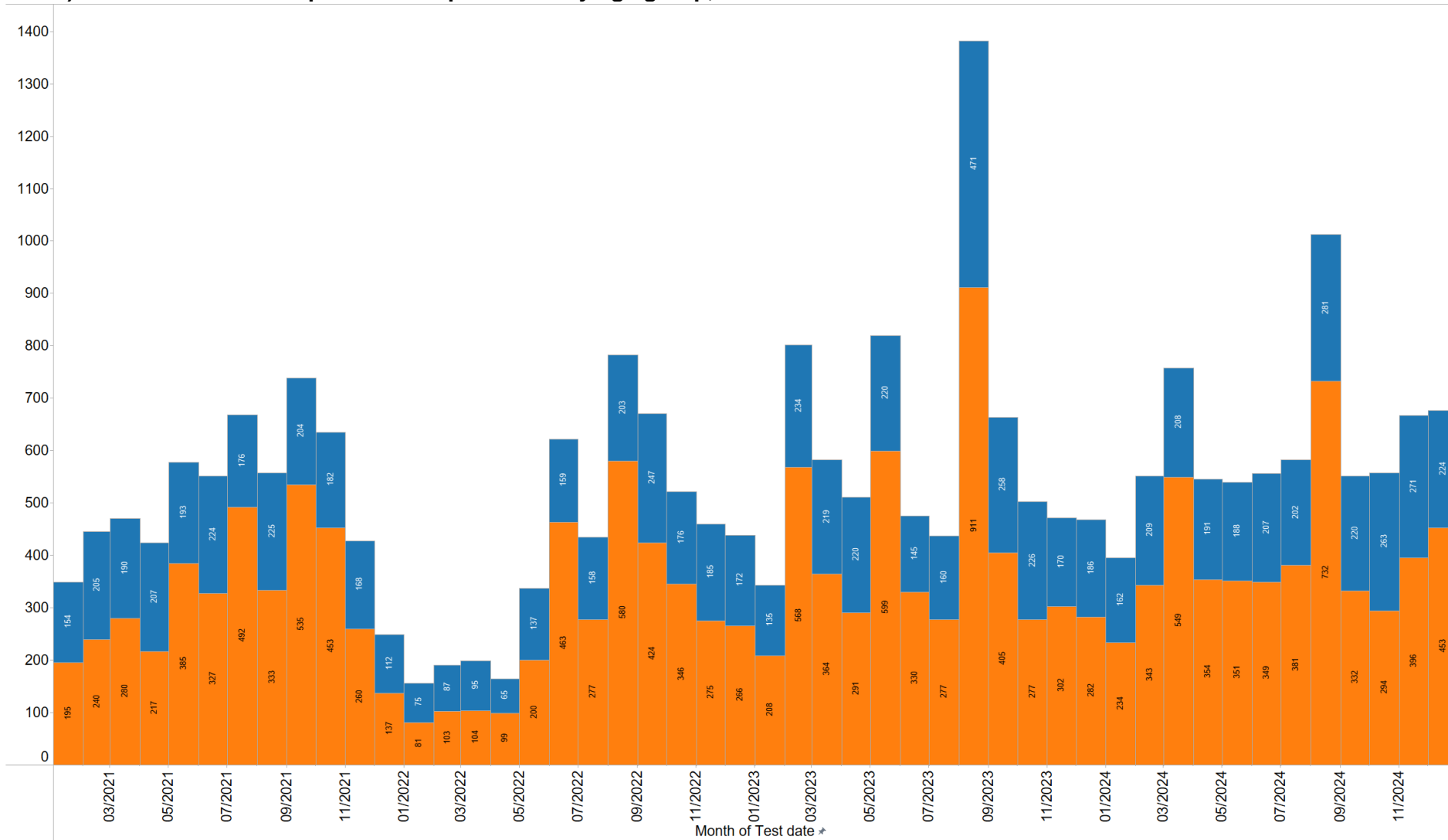

3. Overview of STI POC patient testing from Q1 2021 – Q4 2024

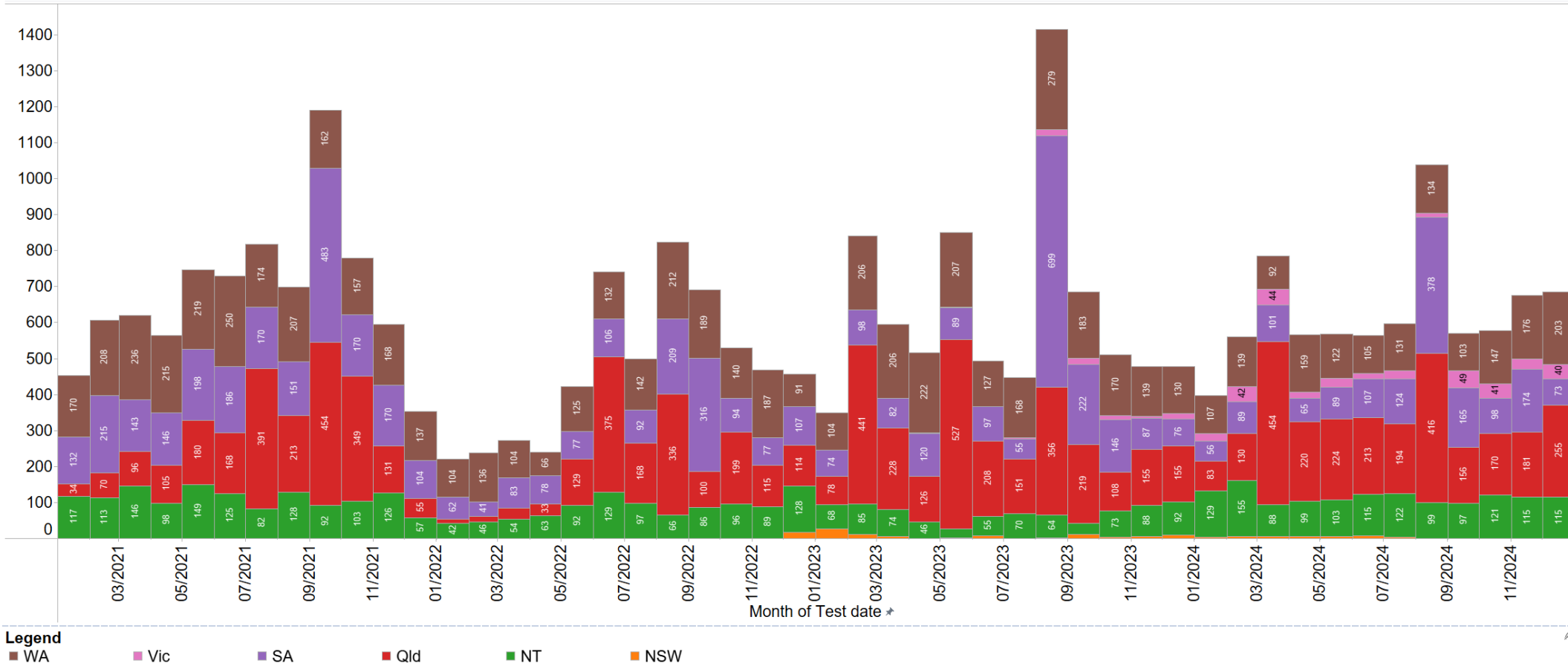
a) Number of STI POC patient tests per month by age group, Q1 2021 – Q4 2024

b) Number of STI POC patient tests per month by state/territory, Q1 2021 – Q4 2024

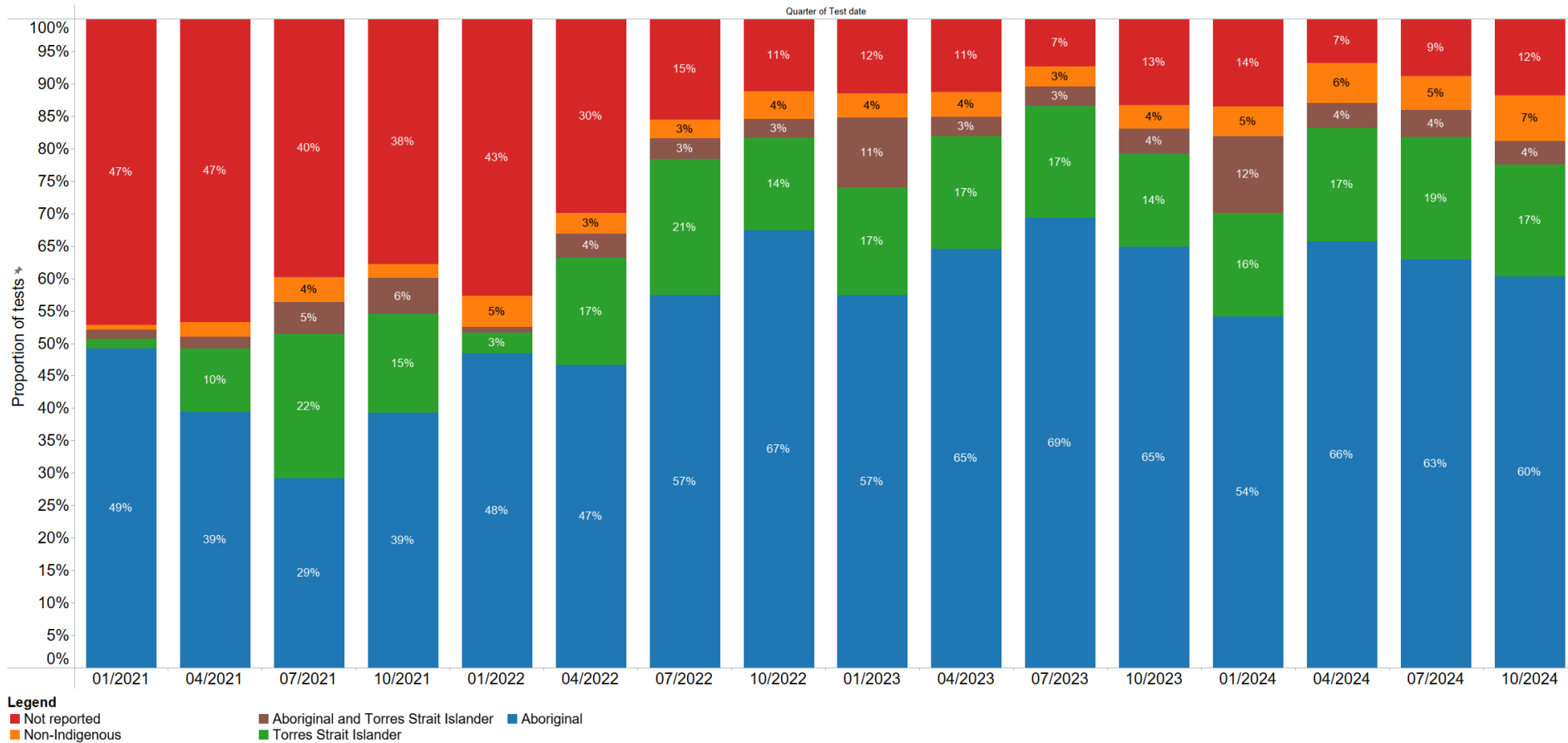

c) Proportion of STI POC patient tests per month by Aboriginal and Torres Strait Islander status, Q1 2021 – Q4 2024

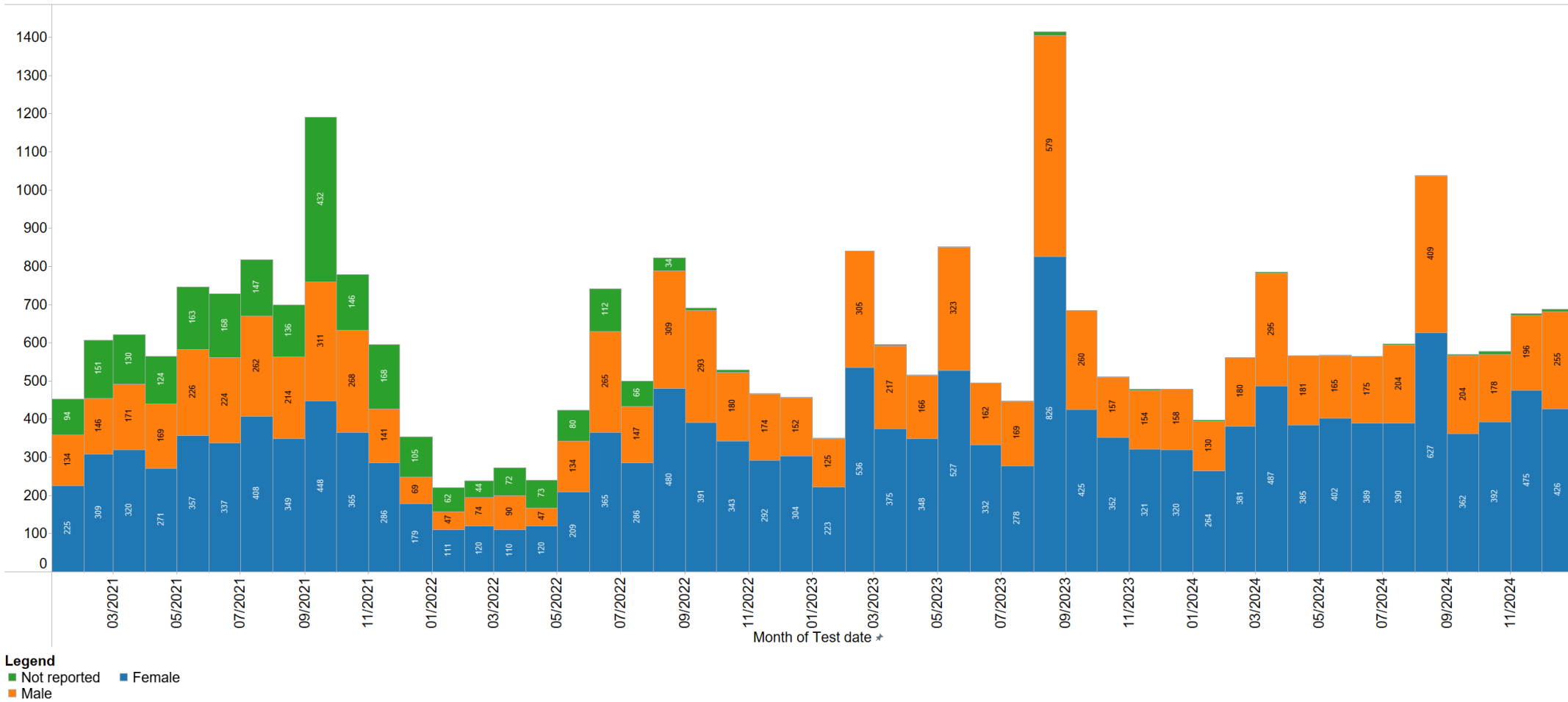

Note: The proportion of *not reported* has decreased over time following improved data capture across the network

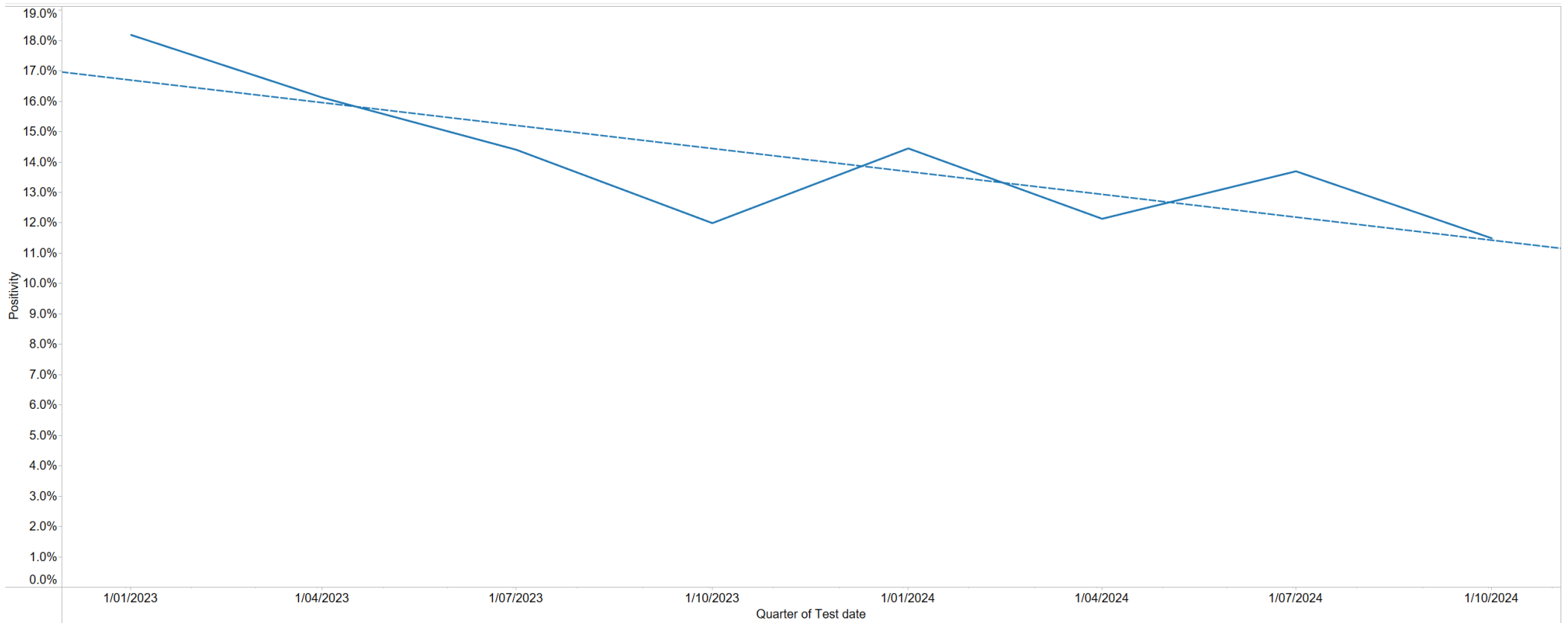

a) Overall CT/NG/TV POC test positivity, Q1 2023 – Q4 2024



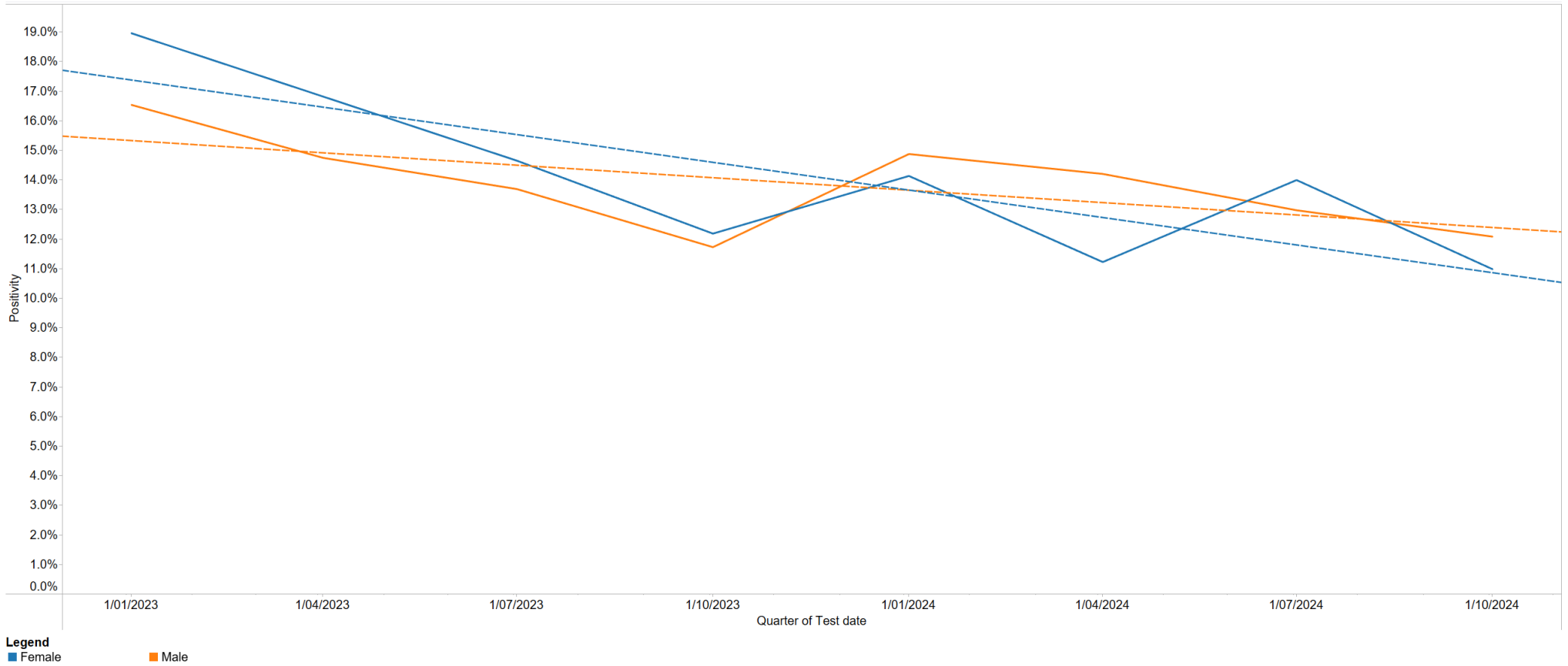

b) CT/NG/TV POC test positivity by Gender, Q1 2023 – Q4 2024



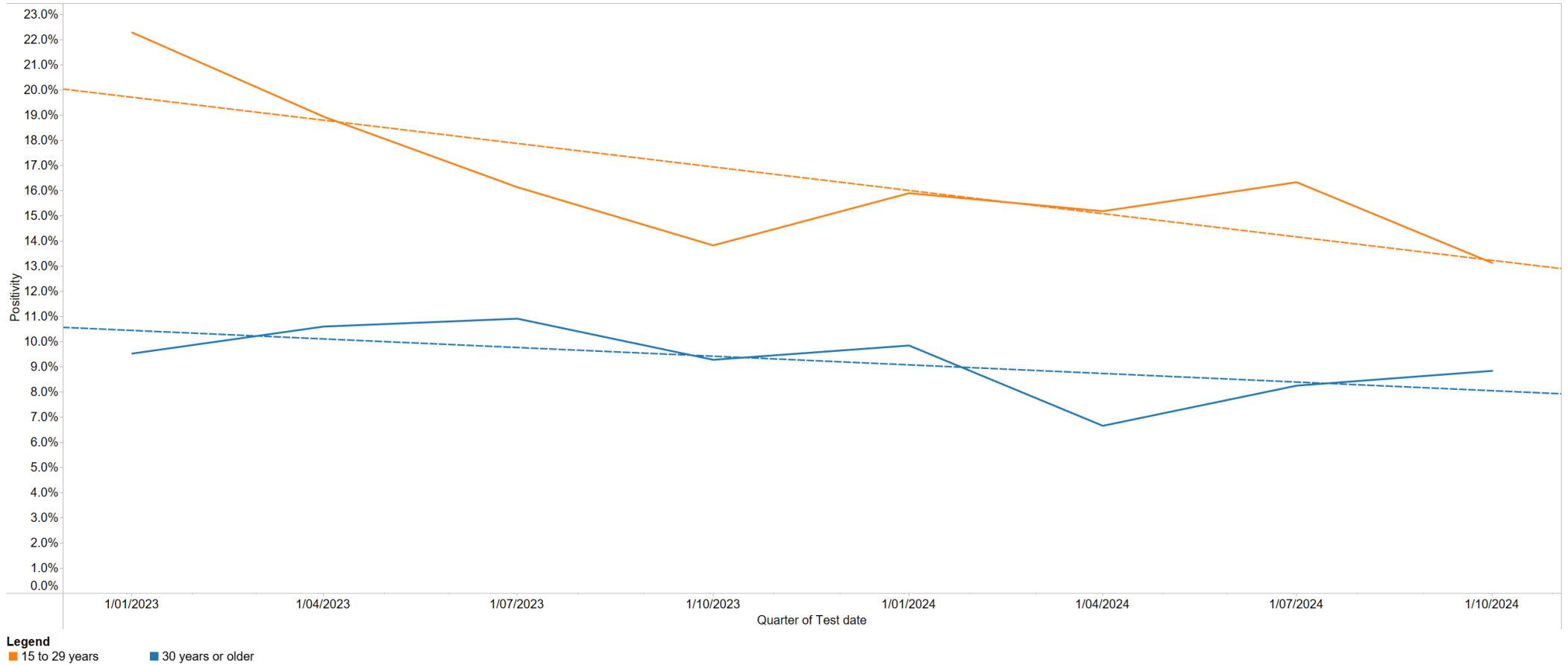

c) CT/NG/TV POC test positivity by Age, Q1 2023 – Q4 2024



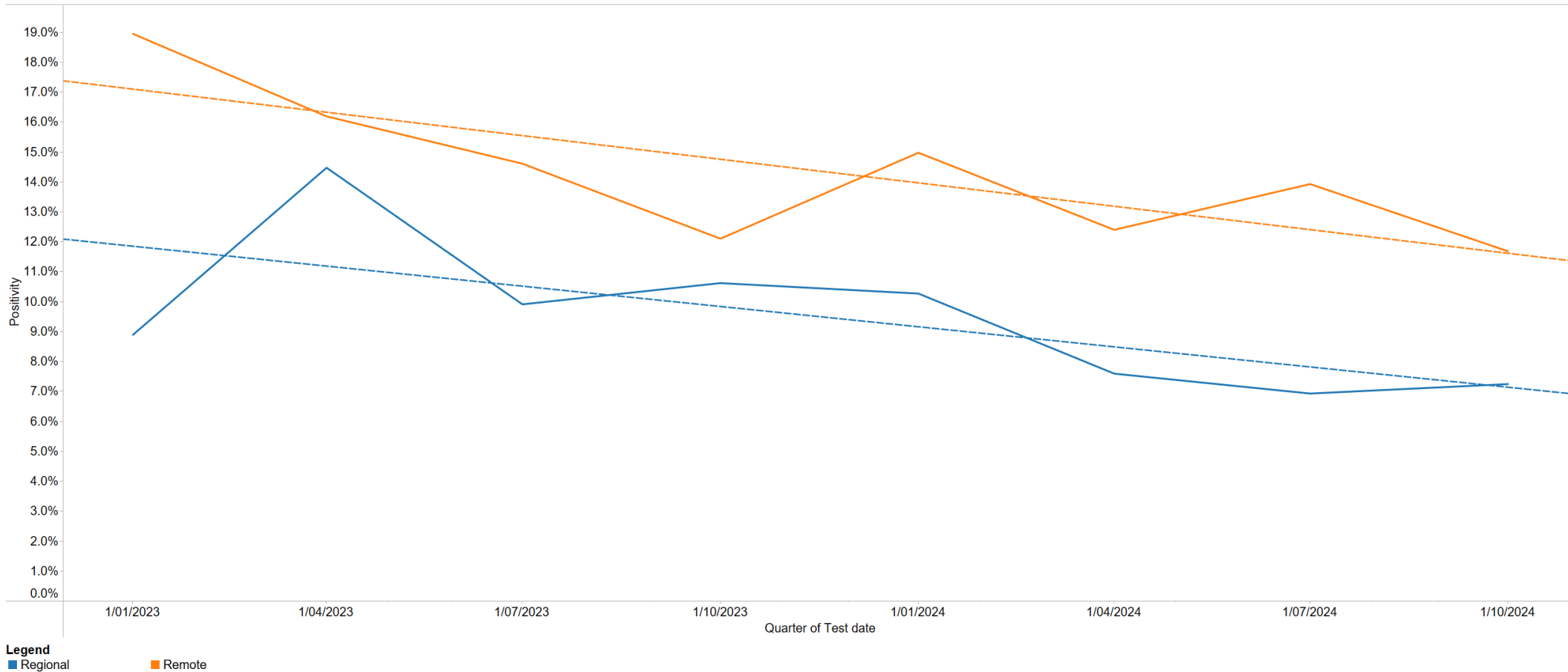

d) CT/NG/TV POC test positivity by Remoteness, Q1 2023 – Q4 2024



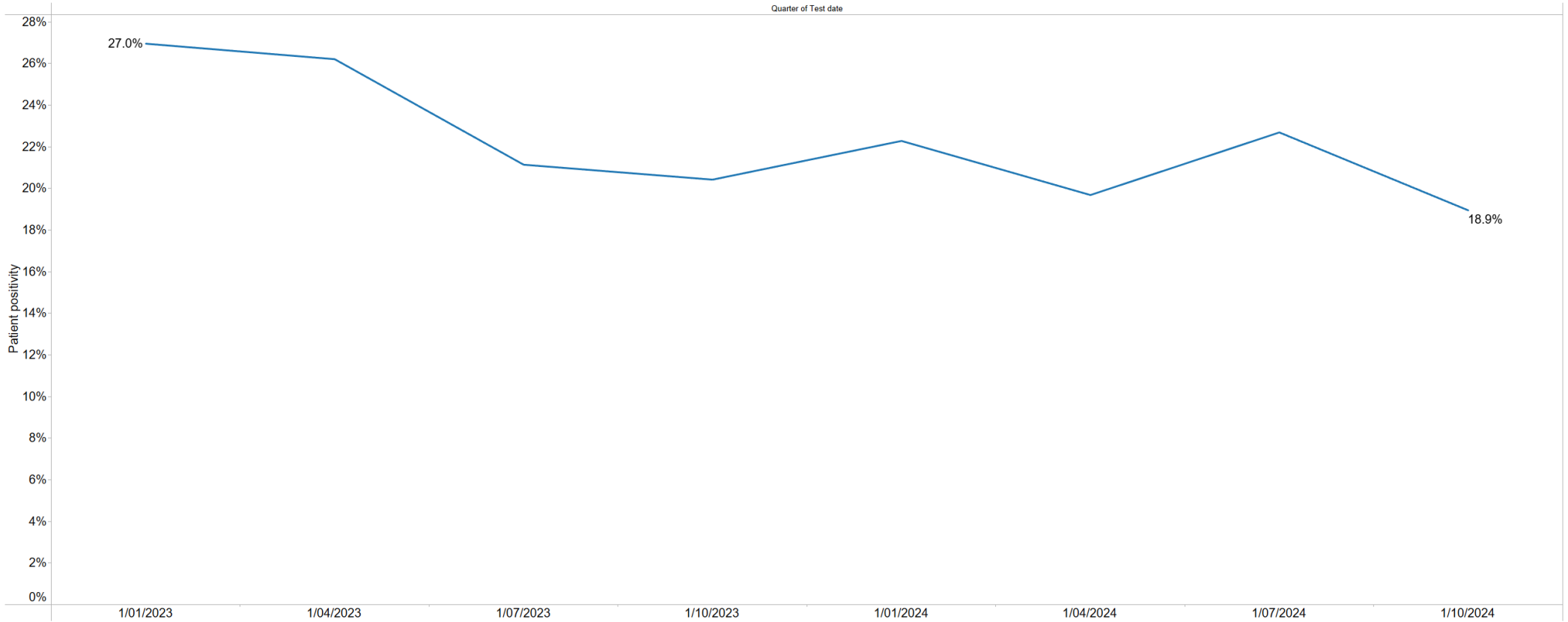

e) Patient positivity, Q1 2023 – Q4 2024



Patient positivity is the number of people who had any positive test result divided by the number people who had both a CT/NG and a TV test.
